

# CLASS 1 TRUCK DRIVER TRAINING



In partnership with Professional Transport Driver Training School we are pleased to offer:

The **244 Hour, Professional Entry Level Truck Driver Training program** consists of: Classroom Theory (delivered virtually - 80 Hrs), Practical, observation, & in-cab training (160 Hrs), and Practical testing with Manitoba Public Insurance (4 Hrs).

**Prerequisites required prior to acceptance:** (Refer to info on next page)

- Minimum 18 years of age
- Hold a valid full Class 5 license (stage F)
- Class 1A license (Class 1 authorized Instruction/Learners Permit)
- Driver's Abstract
- Authorized Air Brake Permit (have an "I" endorsement/Learners)
- Valid medical record on file with Manitoba Public Insurance

Once the prerequisites have been met, UCN will issue a **"conditional acceptance"** letter that can be provided to sponsors. Final acceptance will be verified when payment is confirmed.

## Two intake dates to choose from:

**Intake 1:**(EXT.0250 SR31) February 21, 2023–April 3, 2023, or

**Intake 2:**(EXT.0250 SR32) March 21, 2023–May 2, 2023

**Location:** UCN Building 1485 3<sup>rd</sup> Street North Swan River, MB

**Training Hours:** Monday to Friday 8:00am – 4:30pm (Saturday training may be scheduled)

**Cost:** \$12,650.00 per student (Includes course materials plus 2 attempts at Manitoba Public Insurance road tests)

# CLASS 1 TRUCK DRIVER TRAINING

## Prerequisite Information

### Prerequisites required prior to acceptance:

1. **Minimum 18 years of age**
2. **Hold a valid full Class 5 license (Stage F)**
  - a. A valid full class 5 driver's license is needed (authorized instruction or learners permit is not acceptable)
3. **Knowledge tests/Authorized Instruction Permits (Learners):**
  - o For a Class 1 license and for airbrake knowledge tests, applicants must pass the knowledge test with Manitoba Public Insurance (MPI) for the class of license they are applying for. This is not an open book test and cellular phones or electronic devices cannot be used during the test. The knowledge test charge is \$10 (subject to change) per test. Only one knowledge test per class of license (Class 1 to 4) is allowed per day. You may repeat a Class 1 or Air Brake knowledge test on the next working day.

4. **Valid medical record on file with Manitoba Public Insurance**
  - A driver applying for Class 1 license must file a mandatory [Medical Examination Report](#) with Manitoba Public Insurance (MPI). This report must be approved by [Driver Fitness](#) prior to obtaining your authorized instruction. Applicants are permitted to take the Class 1 knowledge test before the Medical Examination Report is approved. The medical report is valid for six months from the date your physician completes it. Your authorized instruction must be obtained within this six-month time frame.
